January 23, 2013 Commissioners Workshop

Workshop began at 7:00 pm.

Present were: Commissioners Atwell, Barss, Chandler, Spackmann, Waite; Secretary Petkus, D/P Chouinard, D/T Perkins. Please see sign in sheet for others in attendance.

- 1. Flag salute/moment of silence recognized for departed members/troops overseas.
- 2. Approve Minutes: None.

3. <u>Secretary Update – Joyce Petkus</u>

Law and Management Conference in March: Justin Burwell and Stephanie
Burwell have requested permission to attend. Permission granted to Justin and
Stephanie to attend. Brief discussion, anyone interested in attending must
submit paperwork no later than February 13th Commissioners meeting, Joyce to
register as they are approved; added to March meeting agenda for resolution.

4. Purchasing Update - Jill Chouinard

- Chief asked her to look into a 5 gas, gas meter, has not heard back on what the 5th gas is that he would like in the meter, so does not yet have that quote ready.
- Worked on getting a better price for the Holmatro cutter with Garrison, including free shipping. Brief discussion, will order it tomorrow; money to come out of rescue account.
- Gear fitting scheduled for March 7th and March 28th, Co #1 5-9 PM. Sent out email for lists from each company of those who need gear, none received.
- Still waiting for Chris Courtois' pager from Co #4.
- Still no LDDS form received regarding the lost uniform coat.
- AFG: still have heard nothing. Brief discussion; fit test machine and thermal imaging cameras were requested.
- Recently applied for the Fire Prevention & Safety Grant.
- Dress uniform fitting scheduled for February 17th at Co #1 at 10 am. Received list from Co #3 only. Brief discussion; lists due no later than February 6th. D/C Davis noted that no one from Co #1 needs a uniform. Jill to ask Chief to send out over the pager tones, as well as another reminder email. Joyce noted they are really trying to put as much info on the Firetracker calendar as another tool to keep everyone informed of what is going on in the District.

6. Commissioner Updates:

Jack Atwell

- Co #1 has a new applicant, Tyler LaHart, that lives just outside the District.
 Brief discussion: Co #1 to move forward with application.
- Physicals coming up/by law updates, let's get it all done before the deadlines!
- OSHA training has started; great attendance, thanked everyone for the effort to get it out of the way early this year.
- Jaws maintenance has not been done since 2011; he will work with Jill to get it done. Brief discussion.
- Bill Goldfeder Conference: was approached by some firefighters if the Board was paying for them. Commissioner Spackmann noted his understanding is that GFD members get in free.
- Questioned if contracts are needed for air compressor, SCBA maintenance.
 Jill noted in her discussions with the vendor, we do not.
- MacBoston conference on February 16th at Rexford. Joyce noted it is on Firetracker under the training section and also sent an email out about it.

- Asked if anyone looked at the quote from Munter regarding the canopy extension at Co #2. Lengthy discussion followed. Tabled until at least Co #3 roof is settled.
- Need some heat in the pole barn for the frozen water, fire police and Argo. Co #2 has a furnace, Toby Middlebrook willing to do the work if we buy the parts. More discussion continued, including cost of heating annually. Will need approx \$1500 to purchase copper line, power vent and thermostat, and then approx. \$1500.00 per year to heat.

ground channel, the County does not want fire police on the radios, possible purchase of repeaters. Jill to contact the Chief as to why the Chief wants the 4 radios and get back to the Board, and D/C Ellsworth to contact Galway Chief regarding the success of the repeaters.

7. Reports of the Chief/Chief Officers:

Chief Lant:

Not present this evening.

D/C Davis:

- Attendance is up.
- Lights falling off the side of the building. Brief discussion; Commissioner Spackmann to contact the electrician.
- The MacBoston truck is going to stay here until the spring if it is alright with the Board; the company is okay with it as well.

D/C Middlebrook:

- Would like to order an electric positive pressure fan; the fan they have now is very old and not working very well. Brief discussion; a new fan costs about \$3800. A/C Petkus noted he and D/C Ellsworth are going to a fire show in February; they can look into some of the equipment the District is looking for.
- Part delivered to the Town garage for the District's mechanic; given to D/P Chouinard for delivery to Dave Kenyon.

D/C Ellsworth:

- Last month the Board approved donating some of the 3" hose; he will be working on that.
- Have 2 foam pros that don't really get used that much. Edinburg is in dire need of one, would like to loan one to them. Commissioner Spackmann and Joyce to work on loan form and email to D/C Ellsworth.
- Asked if there is an update from Munter on the roof; Commissioner Chandler noted they are waiting for warmer weather. Brief discussion continued.
