


**ANNUAL ELECTION
OF THE GREENFIELD

On December 9, 2025

NOTICE IS HEREBY GIVEN that the Annual Election of the Greenfield Fire District will take place on December 9, 2025 between the hours of 6:00 p.m. and 9:00 p.m. at the Greenfield Fire District Office (building behind the firehouse), 13 South Greenfield Road, Greenfield Center NY, for the purpose of electing a Fire Commissioners, for a five (5) year term, commencing January 1, 2026 and ending December 31, 2030; All voters residing in the Fire District and registered with the Saratoga County Board of Elections on or before November 17, 2025 shall be eligible to vote.

Candidates for District Office shall have filed their names with the District Administrator/Secretary of the Greenfield Fire District at the District Office located at 13 South Greenfield Road, Greenfield Center, NY, and in accordance with the District Election Policy no later than 20 days before the election, 3:00 PM EST November 19, 2025.

THE BOARD OF FIRE COMMISSIONERS OF THE GREENFIELD FIRE DISTRICT ADOPTED A RESOLUTION ON October 9, 2025, AUTHORIZING, PURSUANT TO ARTICLE 11-A OF THE GENERAL MUNICIPAL LAW OF THE STATE OF NEW YORK, A PUBLIC REFERENDUM OF ELIGIBLE VOTERS OF THE GREENFIELD FIRE DISTRICT.

THE BOARD IS SEEKING APPROVAL OF AN AMENDMENT TO THE FIRE DISTRICT'S DEFINED BENEFIT SERVICE AWARD PROGRAM WHICH WAS ESTABLISHED EFFECTIVE JANUARY 1, 2005. THE PROGRAM IS SPONSORED BY THE FIRE DISTRICT, AND IS ADMINISTERED BY THE BOARD, FOR ACTIVE VOLUNTEER FIREFIGHTER MEMBERS OF THE GREENFIELD FIRE DEPARTMENT.

THE AMENDMENT WOULD BE EFFECTIVE JANUARY 1, 2026 IF APPROVED. THE AMEND-

MENT WOULD INCREASE THE MONTHLY SERVICE AWARD FROM \$20 TO \$30 FOR EACH YEAR BEGINNING AFTER DECEMBER 31, 2025 IN WHICH AN ACTIVE VOLUNTEER FIREFIGHTER MEMBER EARNS A YEAR OF SERVICE CREDIT UNDER THE SERVICE AWARD PROGRAM POINT SYSTEM.

THE COST OF FUNDING THE GREENFIELD FIRE DEPARTMENT SERVICE AWARD PROGRAM FOR THE CURRENT PROGRAM IS ESTIMATED TO BE \$110,000 (\$733 PER PARTICIPANT) IN CALENDAR YEAR 2026. THE ANNUAL COST OF THE PROPOSED AMENDED PROGRAM FOR CURRENT PARTICIPANTS IS PROJECTED TO BE \$150,000 (\$1,000 PER PARTICIPANT). THE ANNUAL ADMINISTRATION FEES WILL NOT CHANGE AS A RESULT OF THE AMENDMENT.
